Notice of Workshop to Solicit Comments on Proposed Temporary Regulation

The Nevada State Board of Cosmetology 1785 E. Sahara Avenue, Ste #255 Las Vegas, Nevada 89104 (702) 486-6542 is proposing the Adoption of regulations pertaining to chapter 644 of Nevada Administrative Code. A workshop has been set for 1:00pm January 23, 2005 at Nevada State Board of Cosmetology meeting room.
