NRS 644.190 Unlawful practices without license; exceptions
Every weekend in Nevada there are hundreds of both licensed and unlicensed persons working in hotels and wedding chapels performing cosmetological services for wedding parties. This has been an ongoing issue and has become unenforceable and needs to be addressed. Other laws that may need to be reviewed or revised under this topic are:
NRS 644.460 Exemptions
NRS 644.475 Styling of hairpieces: restrictions.,
NRS 644.490 Additional penalties for person who engages in certain conduct without license; authority of Board to issue citations and orders to cease and desist; administrative fines; appeals.
In addition, an administrative code may need to be revised:
NAC 644.380 Place of practice: Licensed cosmetological establishment; exceptions.,

NRS 644.473 Unlawful acts concerning cutting men's hair and practice of barbering.
This law may require clarification. Other laws/regulations that may need to be reviewed under this topic are:
NRS 644.0225 "Cosmetological establishment" defined
NRS 644.200 Cosmetologists: Qualifications for examination.,
NRS 644.204 Hair designers: Qualifications for examination.,
NRS 644.360 Display of license; limitation on persons to whom space may be leased; limitation on persons who may be employed.,
NRS 644.460 Exemptions., NAC 644.115, NAC 644.308.
NRS 644.475 Styling of hairpieces: Restrictions.

7. Review and possibly formulate revisions for submission to the 2015 legislature to
NRS 644.248 Hair braiders: Scope of examination.
All of the other statutes relating to "Scope of examination" such as cosmetologists, electrologists, hair designers, nail technologists, demonstrator of cosmetics, aestheticians, (NRS 644-240 to NRS 644-247) have the following language:
"Such other demonstrations and tests as the Board requires".
Adding this language will keep our statutes uniform in their language.

8. Review and possibly formulate revisions for submission to the 2015 legislature to
NRS 644.375 and 644.3777 Food and beverage sales.
An issue that comes up frequently is the ability of licensees to offer alcoholic beverages to clients and also the ability of the licensee to partake of alcohol while working. We currently have no laws or regulations prohibiting either and there is a need to clarify this.

Other laws that may need clarification is
NRS 644.430 Grounds; authorized disciplinary action; orders imposing discipline deemed public records.
