5. Review and possibly formulate revisions for submission to the 2015 legislature to create a new definition for Advertising. Every weekend in Nevada there are hundreds of both licensed and unlicensed persons working outside of the scope of a cosmetological establishment. The intent of this addition to Chapter 644 is to create language that allows the board to take action in order to prevent those individuals who are doing so from advertising to the public. In addition to creating the above,
NRS 644.430 Grounds; authorized disciplinary action; orders imposing discipline deemed public records may need to be revised and
NAC 644.700 Schedule of fines; disciplinary hearings.(For Possible Action)

6. Review and possibly formulate revisions for submission to the 2015 legislature to create the possibility of a shampoo assistant. There is a need to address the ability of a salon to utilize licensed or pre-licensed individuals for simple assistant type tasks within the cosmetological establishment. We intend to explore this topic and possibly formulate new regulations to allow this. For Possible Action)

7. Review and possibly formulate revisions for submission to the 2015 legislature to
NRS 644.331 Registration of natural persons engaged in practice of threading and owners and operators of facilities in which natural persons engage in practice of threading; inspection of facilities by Board.

Normally any services outside of the scope of cosmetology must be practiced in a separate room inside the salon. This was never established within the law for threaders and some clarification is needed as to the ability of registered threaders to practice on the floor of a licensed salon or do they need to be in a separate room as other non cosmetological services have been relegated.

Additionally,

NAC 644.307 (Lease of space to certain persons) may need some clarification. (For Possible Action)
