This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would designate the Board staff as the contact for any change of location. (For Possible Action)
7. Review and possibly formulate revisions to the 2015 legislature for
NRS 644.130 Record of licenses; disclosure of information
This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would allow the Board staff to record multiple places of business for any licensee. (For Possible Action)
8. Review and possibly formulate revisions to the 2015 legislature for
NRS 644.095 Approval of device used in cosmetology
This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would allow the Board to ban certain devices and would not allow those devices to be located within a cosmetological establishment. (For Possible Action)
9. Review and possibly formulate revisions to the 2015 legislature for
NRS 644.170 Deposit of fees and receipts
This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would designate the Board staff to make all deposit of fees. (For Possible Action)
10. Review and possibly formulate revisions to the 2015 legislature for
NRS 644.0203 Advertising
This is a final discussion of the possible addition of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the

Nevada State Board of Cosmetology. The proposed revisions would require all licensees and cosmetological establishments to list their license number in all advertising. (For Possible Action)

11. Review and possibly formulate revisions to the 2015 legislature for
NRS 644.473 Unlawful acts concerning cutting of men's hair and practice of barbering

This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would reduce from 400 hours to 0 hours of additional training for a barber to sit for the hair designer examination and would increase from 400 hours to 600 hours of additional training for any barber who requests to sit for the cosmetologist's exam. (For Possible Action)

12. Review and possibly formulate revisions to the 2015 legislature for
NRS 644.248 Hair braiders: Scope of examination

This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would bring the hair braiders license requirements under the same wording as all other license requirements of the Board. (For Possible Action)

13. Review and possibly formulate revisions to the 2015 legislature for
NRS 644.0293 "Shampoo Technologist" defined

This is a final discussion of the possible addition of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would establish a new licensed branch of cosmetology for shampoo technologists. (For Possible Action)

14. Review and possibly formulate revisions to the 2015 legislature for
NRS 644.331 Registration of natural persons engaged in practice of threading

This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would bring the threaders under the same sanitary regulations as all other licensees as directed by the legislature. (For Possible Action)

15. Review and possibly formulate revisions to the 2015 legislature for
NRS 644.320 Expiration of license

This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would allow

licensees to choose either a 2 year or 4 year renewal period. (For Possible Action)

16. Review and possibly formulate revisions to the 2015 legislature for **NRS 644.472 Unlawful for animal to be on premises of licensed establishment for hair braiding or cosmetological establishment; exception**

This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would bring the statutes in conformance with the Americans with Disabilities Act. (For Possible Action)

17. Review and possibly formulate revisions to the 2015 legislature for **NRS 644.370 Supervision by licensed person**

This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would clarify the supervision requirements in a cosmetological establishment. (For Possible Action)

18. Review and possibly formulate revisions to the 2015 legislature for **NAC 644.330 Plumbing**

This is a final discussion of the possible revision of this regulation before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions to regulation will be discussed at a public workshop and a public hearing before any changes to the regulation would be enacted. (For Possible Action)

19. Review and possibly formulate revisions to the 2015 legislature for **NRS 644.200 Cosmetologists: Qualifications for examination**

This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would modify the number of hours required for a cosmetologist to sit for examination. (For Possible Action)

20. Review and possibly formulate revisions to the 2015 legislature for **NRS 644.315 Requirements for issuance and renewal of limited license for person licensed in Nevada, another state, or territory or District of Columbia**

This is a final discussion of the possible revision of this statute before it will potentially be discussed for possible action at the May 5, 2014 meeting of the Nevada State Board of Cosmetology. The proposed revisions would modify the existing resort license to allow licensees to perform certain services outside of a licensed cosmetological establishment. The cosmetology

services would be allowed to be performed for weddings and other special events. (For Possible Action)
