8. Discussion and approval of proposed regulations. The Board will consider proposed regulations supporting the laws previously passed during the last legislative session. The topics discussed will include banned devices, hours of teaching for the apprenticeship program, practices constituting disciplinary action, use of chemicals in hair straightening products, and other regulations pertinent to the laws. 9. Discussion and approval of voluntary cosmetology substance abuse program for licensees. The Board will discuss and vote on the proposed substance abuse program for licensees developed by staff. (for Possible Action)
10. Discussion of the removal of superfluous hair. The Board will discuss the removal of superfluous hair in the practice of cosmetologists' scope of services. The Board may interpret the relevant statutes or regulations and/or direct Staff to draft a policy on this issue. (for Possible Action)

11. Discussion on closing without notice. Staff reports- to the Board on the common policy by cosmetological establishments to close with limited or no notice. The Board will discuss and possibly develop a policy to address this issue. (for Possible Action)
12. Discussion regarding human trafficking in the cosmetology industry. The Board will discuss the problem of human trafficking in the cosmetology industry, to include commercial sex activity, and consider ways to provide assistance and referrals. (for Possible Action)
