Some of the proposed changes to Chapter 644 of the Nevada Revised Statutes include: a) Verbiage clarification for administrative purposes, b) introduction of a lifetime license option, c) additional grounds for disciplinary action, d) qualifications for instructors (An Action Item)

The topics discussed included banned devices, hours of teaching for the apprenticeship program, practices constituting disciplinary action, use of chemicals in hair straightening products, and other regulations pertinent to the laws.
