10. Proposed regulation required by the passage of AB-246 requiring changes for Barbers. These include increasing 400 hours to 600 hours for a Barber to become a Cosmetologist; decreasing 400 hours to 0 hours for a Barber to become a Hair Designer; and for Nail Technologists working within a Barber Shop to have a separation of work area.
